#### Eligibility Requirements:

Applicants qualify to receive a Full Scholarship, covering the full \$335 Farm Camp fee, if one of the following requirements are met:

1. Parent/Guardian or child are beneficiaries of one of the benefits listed on page 1 of this application (ie. SNAP, TANIF, Medicaid, etc.).

Are you or your child currently a beneficiary(ies) of the following benefits? *(select all that apply)*

- Public Housing or Section 8 Housing Benefits
- Temporary Assistance for Needy Families (TANIF)
- Free and Reduced School Lunch Program in one of the following school districts:

  - Arlington Public Schools (APS)
  - DC Public Schools (DCPS)
- Supplemental Security Income Program (SSI)

May 15—Notification of Scholarship status to all families.

May 28 – Online Registration due (for English speakers ONLY) and Printed Registration Packets due (for Spanish speakers ONLY).
